### RULES OF ENTRY

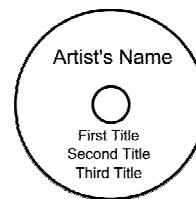
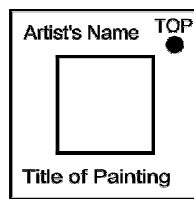
**Entry Deadline: September 14, 2009**

**1. Entry Fees (non-refundable).** \$35 for up to 3 entries and \$5 for each additional submission, up to 10. Make check or money order payable to **Louisiana Art and Artists' Guild**.

**2. The CD** and CD case should be clearly labeled with artist's name and first three titles of artwork with a Sharpie felt tip pen (see below). **Use no adhesive labels or tape. Image file name must match exactly the title of the painting as listed on the entry form.** Use JPEG format with at least 1000 pixels on the longest side. Images must represent the painting exactly without extraneous background or framing. **CDs will not be returned.** Use of CDs is preferred to slides.

**3. Slides**, in a 2"x2" 35mm format, must be in plastic or cardboard mounts, with no glass or tape. If you wish your slides to be returned, **please send a second self-addressed, stamped #10 envelope.**

Clearly label slides and CDs as indicated:



**4. Notification** of the juror's selection will be sent by **November 2, 2009**. Provide a self-addressed, stamped #10 envelope for notification.

**5. Size and Framing.** Works on canvas or board must be framed unless painted on gallery-wrapped canvas. All shipped works and any work 22" x 30" or larger must use Plexiglas (no glass). Screw eyes and wire should be properly attached to all artwork. Mats should be white or a light neutral tone. The maximum framed size is 48" x 48". **The artist's name and title of work should be clearly identified on the back of each painting.** Non-compliance may void the entry.

**6. Eligibility.** Artwork must be original and created within the last two years. Photographs and digitally-created or enhanced works are not acceptable. No nudes, giclées, serigraphs and/or reproductions are appropriate. Artwork previously exhibited in the River Road Show is not eligible.

**7. Exhibition.** No artwork may be withdrawn, returned or substituted during the exhibition.

**8. Liability.** The Louisiana State Archives, its employees, LAAG, and/or any of its members, will not be held responsible for any loss or damage to artwork. Insurance should be purchased by the individual artist.

**9. Sales.** Exhibited artwork will be labeled with the selling price or NFS (not for sale) designation. **No commission is charged for sales.** Works sold will be given to the purchaser at the completion of the exhibition.

**10. Delivery of Work.** Accepted work may be hand-delivered or shipped prepaid by **UPS**, insured at the artist's expense. **Hand-delivered work** will be received only on **Tuesday, December 1, 10am-1pm** at the Louisiana State Archives, 3851 Essen Lane, Baton Rouge, LA. **Shipped work** must be securely packaged in a legibly addressed reusable box arriving no later than **Friday, November 20**. Shipping charges (both directions) are to be arranged by the artist. A handling fee of \$20 (payable to LAAG) is assessed on all shipped works. **Detailed instructions will accompany letters of acceptance.**

**11. Return of Work.** Hand-delivered work should be picked up on **Saturday, January 30, 10am-1pm**. Shipped works will be returned via prepaid UPS using the artist-provided durable, reusable box. Written shipping instructions and prepayment of return shipping costs are required.
